Dear Levy Chairperson

Subject: Levy Issue 27

My name is Jill Hiles. I am the Akron Council of PTA (ACPTA) President. I've been involved with PTA since 2013. PTA's mission is to make every child's potential a reality by engaging and empowering families and communities to advocate for all children.

One way that this mission can be achieved is through supporting your districts school levies. This November the community will vote on Issue 27 Akron City School District. The first item proposed is a bond for the purpose of constructing, furnishing, and equipping a new high school to replace North High School on the existing site with site improvements to be repaid over a period of 37 years. This is the area of Akron that is showing growth. The current facilities are falling down and creating an unsafe learning environment. A second item is a proposed levy in conjunction with the rebuild is a levy which is a property tax outside the 10 mill limitation. Finally, a third proposed item is a levy – an additional tax to pay current operating expenses.

On behalf of ACPTA with PTA units, we are providing our official endorsement of Issue 27.
